- First time vendor with the AFM
- Beginning farmer

• Live within 150 mile radius of Athens, OH

There are no product requirements for this grant, but recommended products include:

- Fruit
- Eggs
- Dairy
- Honey
- Winter produce

Two annual winners will be granted a free stall fee, worth \$250 each, and will receive recognition and support as new vendors. Please note that winners will still be required to pay a \$225 membership fee, which is separate from the stall fee.
